Dickson moved second by Barkley to have Frontier as the internet service provider. Roll call on motion: Dickson, Dreyer and Barkley-Yes

Dickson moved second by Dickson to receive maximum pay for 2024. Roll call on motion: Dickson, Dreyer and Barkley- Yes

Dickson moved second by Barkley to have copies at .25 per page and if mailed the current postage rate. Roll call on motion: Dickson, Dreyer and Barkley- Yes

Dreyer moved second by Dickson to allow the clerk to purchase supplies. Roll call on motion: Dickson, Dreyer and Barkley-Yes

Barkley moved second by Dreyer to pay .67 cents per mile for travel outside of Township. Roll call on motion: Dreyer, Barkley and Dickson-Yes

Dreyer moved second by Dickson to have two Trustees know of any hired labor. Roll call on motion: Dreyer, Dickson and Barkley- Yes

Dreyer moved seconded by Barkley to have Sedgewick as our Twp. Managed care organized thru workers comp. Roll call on motion: Dreyer, Dickson and Barkley- Yes

Dickson moved second Dreyer to have the Trustees serve as Elm Valley Joint Fire District Board members. Roll call on motion: Dickson, Dreyer and Barkley- Yes

Dickson seconded by Dreyer to give the Tractor operator, Snowplow and General Labor a 2.5% increase which would be \$25.63 per hour Roll call on motion: Dreyer, Dickson and Barkley- Yes

Barkley moved second by Dickson to keep active money in FCB and Star Ohio. Roll call on motion: Dickson, Dreyer and Barkley- Yes

Dreyer moved 2nd by Barkley to pay Joel Staley Zoning Inspector a 2.5% increase which would be \$527.88 per month Roll call on motion: Dreyer, Dickson and Barkley- Yes

Dreyer moved seconded by Dickson for Reimbursement for Health care Individual up to \$4,950.00 and family \$6,000.00. Roll call on motion: Dreyer, Dickson and Barkley- Yes

Andrew Wick came in to let us know that he will be on the March Primary ballot and shared his background.

Tim Siegfried Came in to give an update for the commissioners. They just received partial approval for the Health Department to move into a new building. This should happen in new year.

Dwight and Melissa Miller came in to get an update on Renergy. Dickson let them know that the Attorney Generals Office denied motion to intervein. Melissa asked about if there is a sound abatement. With the direction of the attorney for Westfield Twp. and Bath Twp. the case is based on air pollution. Melissa shared that within the last month the noise and vibration from the generator has been more disruptive. The Trustees talked with previous board members and they stated that there was a determination on the right of way at for the easement at Mound Cemetery between 1993 and 2000. The Trustees will look into this.
